### **JSA of LIS WAIVER AGREEMENT**

The undersigned is the Parent/Guardian of the Junior Sailor named above. As a requirement for the Junior Sailor's participation in the Junior Sailing Program of the home club identified above ("the Program"), the undersigned, by and on behalf of himself/herself and the Junior Sailor, and their respective heirs, successors, and assigns, hereby agrees to the terms and conditions set forth below:

- 1. The sport of sailing and participation in the Program present certain inherent risks of physical harm as well as property loss. The undersigned acknowledges, accepts, and assumes these risks, and confirms that the Junior Sailor is participating in the Program voluntarily and solely at his/her own risk.
- 2. The undersigned hereby consents to the Junior Sailor's participation in the Program, including without limitation, in all daytime and nighttime regattas, clinics, and other sailing and social activities and events, both on-water and on-land, that are part of, or related to, the Junior Sailor's Program (collectively "Events") in accordance with this Agreement.
- 3. The undersigned further agrees that this Agreement shall apply in its entirety to the benefit of the Program's home club or association, the clubs/sailing associations that host and/or are the on-water and on-shore venues of Events (collectively "Host Club") and to the Junior Sailing Association of Long Island Sound, Inc. ("the JSA"), including without



limitation, to their respective members, officers, directors, trustees, governors, employees, agents, and volunteers.

4. The list of Host Clubs and the 2020 Schedule are available on the JSA website (http://www.jsalis.org). The undersigned further acknowledges that he/she has reviewed the JSA 2020 Schedule prior to executing this Agreement and agrees that changes to the Schedule, including changes of venue, may be made at any time in the JSA's sole discretion.

I have thoroughly read and agree to each of the four provisions listed above. I understand that I am giving my permission for the Junior Sailor named above to participate in all Program Events.



#### **RELEASE AND WAIVER**

- 1. The undersigned agrees that the Junior Sailor's home club or association, the Program, all Host Clubs, and the JSA, and all of their respective members, officers, directors, trustees, governors, employees, agents, and volunteers, as well as all persons acting in a volunteer capacity regarding the conduct of the Program, and/or any Event ("Released Party" or collectively "the Released Parties"), shall not be responsible or liable for the personal injury, death, and/or property loss or damage suffered by the Junior Sailor or any third party ("Loss") arising out of or related to the Junior Sailor's participation in the Program, and/or in any Events, unless such Loss is caused by the negligence of a Released Party. By consenting to the participation of the Junior Sailor in the Program, including any Events, the undersigned, himself/herself and on behalf of the Junior Sailor and their respective heirs, successors, and assigns, hereby waives all claims against the Released Parties for, and releases the Released Parties from, any and all liability, including personal injury, death and property loss or damage claims arising out of the Junior Sailor's participation in the Program, or in any Event (a "Claim") to the fullest extent permitted by law.
- 2. The undersigned, himself/herself and on behalf of the Junior Sailor, and all heirs, successors, and assigns, to the fullest extent permitted by law, hereby waives the right to sue the Released Parties for claims of any kind including without limitation, all claims based upon personal injury, death, and/or property loss or damage, arising out of or related to the Junior Sailor s participation in the Program, and/or in any Events, and hereby releases the Released Parties from all liability arising therefrom.
- 3. The undersigned for himself/herself and on behalf of the Junior Sailor gives permission for the undersigned's and the Junior Sailor's name, voice, and/or photographic likeness to be used by the Program, the Host Clubs and the JSA in all forms and media for the purpose of publicity.

### **MEDICAL AUTHORIZATION**

I hereby authorize an instructor from my Club, Program, Event Host Club, or an adult who bears an electronic copy of this document, to authorize emergency treatment for the Junior Sailor named above in the event that a parent or legal guardian cannot be reached at the time of the emergency.
